



ActiveCrypt Software Single License Agreement

This License Agreement (“Agreement”) is a legal agreement between ActiveCrypt Software (“ActiveCrypt”), and <company> (“Licensee”), and is effective the date Licensee installs, downloads, copies or otherwise Uses **XP_CRYPT for SQL Server** in whole or in part (“Software”). “Use”, “Uses” or “Used” means to access any of the files that are included with the Software, to develop an application that makes use of the Software, to consult any of the documentation included with the Software, or to otherwise benefit from using the Software. The Software is licensed, not sold. If Licensee has obtained a registered license from ActiveCrypt or an authorized reseller, Licensee is considered to be an authorized (“Authorized”) licensee.

1. GRANT OF LICENSE

You may use one copy of the Software activated by an activation key on a single server (virtual or physical) owned, leased, or otherwise controlled by you. License can not be transferred to another server. Server ID (unique server identification tag) is bound to computer name. If you re-install the software of the server, you can re-activate the software with the same activation key. If you have multiple license keys for the Software, you may make and use as many copies of the Software as you have license keys. For purposes of this Agreement, "use" of the software means loading the Software into the temporary or permanent memory of a computer. Installation of the Software on a network server solely for distribution to other computers is not "use" of the Software, and is permitted, as long as you have a license key for each server (virtual or physical) to which the Software is distributed. The Software may not be used on or distributed to a greater number of computers than you have license keys. If you use or distribute the Software to multiple servers, you must ensure that the number of servers does not exceed the number of license keys you have obtained, or you will be in breach of this Agreement.

2. LICENSE RENEWAL

For a period of one year ActiveCrypt agrees to provide free software updates (if and when they become available) of the software purchased (which does not include titles by another name) via internet download. You may renew your license annually (you are required to pay a license renewal fee) to obtain an additional year of free software updates. You are not obliged to renew your license to continue using the software after your license is expired, but you must renew your license if you wish to update the software. Technical support is provided free of charge, but ActiveCrypt reserves the right to limit or cease technical support to any user at any time.

3. REVERSE-ENGINEERING

Licensee acknowledges that the Software, in source code form, remains a confidential trade secret of ActiveCrypt and/or its suppliers and therefore Licensee agrees that it shall not modify, decompile, disassemble or reverse engineer the Software or attempt to do so. Licensee agrees to refrain from disclosing the Software (and to take reasonable measures with its employees to ensure they do not disclose the Software) to any person, firm or entity except as expressly permitted.

4. RESTRICTIONS

The use of the Software may require an “activation key” from ActiveCrypt (or its authorized reseller) for full functionality, and ActiveCrypt reserves the right in its sole discretion to refuse requests for more than one activation key. The activation key may be a printable digital key, a non-printable file, or any other mechanism used by ActiveCrypt for license activation purposes. You agree that you will not attempt to “hack,” “crack,” or otherwise override this activation key.

Licensee may not Use, copy, modify, translate, or transfer the Software, documentation, license key, or any of the files included with the Software except as expressly defined in this agreement. Licensee may not attempt to unlock or bypass any “copy-protection”, licensing or authentication algorithm utilized by the Software. Licensee may not remove or modify any copyright notice, nor the About dialog or the method by which it may be invoked without permission from ActiveCrypt Software. Licensee may not rent or lease the Software. Violations will be prosecuted to the maximum extent possible under the law.

5. LIABILITY DISCLAIMER

The Software is provided as is, without any representation or warranty of any kind, either express or implied, including without limitation any representations or endorsements regarding the use of, the results of, or performance of the product, its appropriateness, accuracy, reliability, or correctness. The entire risk as to the use of this product is assumed by Licensee. ActiveCrypt does not assume liability for the use of this program beyond the original purchase price of the software. In no event will ActiveCrypt be liable for additional direct or indirect damages including any lost profits, lost savings, or other incidental or consequential damages arising from any defects, or the use or inability to use these programs, even if ActiveCrypt has been advised of the possibility of such damages.

6. EXPORT LAW

Licensee acknowledges and agrees that the Software may be subject to export restrictions and controls. Licensee agrees and certifies that neither the Software nor any direct product thereof (e.g. any application software developed by Licensee that uses the Software) is being or will be acquired, shipped, transferred or re-exported, directly or indirectly, into any country prohibited by export restrictions and controls. Licensee bears all responsibility for export law compliance and will indemnify ActiveCrypt against all claims based on Licensee’s exporting the Software.

7. TERMS

This Agreement is effective until terminated. Licensee may terminate it by destroying the Software, all the Redistributable Files Licensee may have distributed, the documentation and copies thereof. This license will also terminate if Licensee fails to comply with any terms or conditions of this Agreement. Licensee agrees upon such termination to destroy all copies of the Software and of the documentation, or return them to ActiveCrypt for disposal.
